

**SPECIAL BOARD MEETING
MINUTES
MAY 7, 2025
CERRO GORDO JUNIOR/SENIOR HIGH STEAM LAB**

The regular meeting of the Cerro Gordo CUSD #100 Board of Education was called to order by President Freese at 6:00 p.m. in the High School STEAM Lab. Members Callaway (via phone call), Curran, Freese, Greenwood, Howell, Miller, and Runyen answered roll call. Also present was Superintendent Weidner.

Curran seconded the motion. Roll call: Greenwood, abstain; Howell, yea; Miller, yea; Runyen, yea; Callaway, yea; Curran, yea; Bebar, yea;. Motion carried 6 yeas, 1 abstain.

President Miller asked for nominations for Secretary for a 2 year term. Miller nominated Callaway. Curran seconded the motion. Runyen made a motion to close nominations and vote. Bebar seconded the motion. Roll call: Howell, yea; Miller, yea; Runyen, yea; Callaway, yea; Curran, yea; Bebar, yea; Greenwood, yea. Motion carried all yeas.

President Miller asked for nominations for Treasurer for a 1 year term. Miller nominated Runyen. Howell seconded the nomination. Miller made a motion to close nominations and vote. Curran seconded the motion. Roll call: Miller, yea; Runyen, yea; Callaway, yea; Curran, yea; Bebar, yea; Greenwood, yea; Howell, yea. Motion carried all yeas.

Superintendent Weidner shared the board meeting dates for the next year. Meetings will be held on the third Wednesday of the month at 6:30 PM in the CGHS Auditorium. Voice vote: all yeas.

Superintendent Weidner shared thank you notes from Mrs. Neaveill, Mr. Willard, and Mr. Jacobs for the board lunch for Teacher Appreciation Week.
