Superintendent Weidner reported the FFA is holding a tractor raffle as a fundraiser this fall; Kirby Medical Group offered athletic physicals on July 16th, part of the fees went to CG Athletics; registration for the new school year starts online on August 1st and new student registration starts on August 4th; the first day of school is August 14th; our average daily attendance increased this year from 414 to 426; teacher inservice days are scheduled for August 12th and 13th; the district hosted Cycle Across Illinois on July 10th; Dr. Weidner and Mr. Willard met the CGB Athletic Boosters incoming president; Dr. Weidner attended the Sangamon Valley CEO board meeting on July 8th; Hayden Rice will participate in the CEO program this year; BLDD is working to finish the 10 year Health Life Safety Report; Beck Tech has installed new cameras; flooring was upgraded in the JH addition hallway; the old lockers in the HS have been removed and will be replaced with lockers that match the other existing panels; cafeteria tables at the elementary school were installed; the A/C in the JH/HS office area and at CGES is being repaired; the video board in the gym is scheduled for delivery and installation on August 12th; the first payment of the tax extension from Piatt County for FY26 was received at the end of June; sales tax revenue from Macon and Piatt counties increased from \$259,731 in FY24 to \$282,383 in FY25; the district received a Freedom of Information Act request from Owen Wang with the Chambana Sun on June 18th that was partially fulfilled; the district received a Freedom
