## REGULAR MEETING MINUTES AUGUST 17, 2022 CERRO GORDO JUNIOR/SENIOR HIGH AUDITORIUM

The regular meeting of the Cerro Gordo CUSD #100 Board of Education was called to order by President Piraino at 6:32 p.m. in the high school auditorium. Members Curran, Freese, Greenwood, Hayes, Piraino, and Runyen answered roll call. Miller was absent. Also present were Superintendent Robinson, Principal Neaveill, and Principal Willard.

Runyen seconded the motion. Roll call: Curran, yea; Freese, yea; Greenwood, yea; Hayes, yea; Piraino, yea; Runyen, yea. Motion carried all yeas.

Principal Neaveill reported new year enrollment; 32 Pre-K (1 to Pershing), 37 Kindergarten, 41 First grade, 25 Second grade (1 to SELA), 35 Third grade, 36 Fourth grade, 27 Fifth grade, total of 234 students (11 students moved out, 15 new students to district). Neaveill received a letter from the Director of Early Childhood Education that Cerro Gordo Elementary had received the Gold Circle of Quality based on last year monitor results. Neaveill thanked Mandi Isaac, Pre-K teacher and Heather Skelley, Pre-K aide for their hard work. Superintendent Robinson thanked Neaveill for her leadership and diligence in the program achieving the highest level of recognition.

Principal Willard reported new year enrollment; 32 Sixth grade, 35 Seventh grade, 35 Eighth grade, 25 Ninth grade, 35 Tenth grade, 25 Eleventh grade, 30 Twelfth grade, 4 to Futures, total 102 students Jr high and 118 Sr high (8 students moved out, 12 new students to district). Willard reported August 11 orientation went well and thanked all of those that helped make the first day successful including Jr/Sr high Student Council and the community. Also discussed were the first day of school assembly and upcoming football scrimmage and game.

Superintendent Robinson spoke of positive parent comments made during orientation, said great job to principals and students especially during the delivery of chromebooks. Robinson spoke of the first day of school assembly and the opening introductions, spoke of time spent with the students of the Elementary during lunch period. Tuck point work at Jr/Sr High is almost complete, waiting on correct bricks to complete the north entrance. Tree dedicated to retired teachers was replaced at the Elementary on 8/16 after damage done by construction crew. Michael Freese and his father will take over care of the tree for his Eagle Scout project.

Budget hearing will be held September 21, 2022 with regular meeting. Other topics of discussion included a question on the status of a proposed HVAC project which would be paid in part with ESSER money, and update on the property recently purchased.

As there was no further action to come before the board, Piraino declared the meeting adjourned at 7:54 p.m.
