

## REGULAR MEETING MINUTES

AUGUST 18, 2021, 6:30PM

### CERRO GORDO JUNIOR/SENIOR HIGH AUDITORIUM

The regular meeting of the Cerro Gordo CUSD #100 Board of Education was called to order by President Piraino at 6:32pm. Members Curran, Freese, Greenwood, Hayes, Miller, Piraino, and Runyen answered roll call. Also present were Superintendent Robinson and Principals Neaveill and Rodebaugh.

Consideration and discussion of consent agenda: Item A, approval of the July 21, 2021 regular meeting minutes, was tabled until the next meeting. Items B-F were considered for approval including payment of the bills totaling \$204,539.36. A motion to approve consent agenda items B-F was made by Freese and seconded by Greenwood. #### Principals' Reports:

The principals shared official enrollment numbers. Principal Neaveill shared that 251 elementary students are attending Cerro Gordo Elementary this year. Principal Rodebaugh shared that 200 students are attending Cerro Gordo Junior/Senior High School this year.

#### Superintendent Report:

Superintendent Robinson provided updates on various facility enhancements including the brick refacing project, anticipated arrival and installation of new windows, and anticipated completion of installation of upgraded playground with poured rubber.

Other Business:

The board discussed the policy of not allowing homeschooled students in the district to participate in athletic activities and the rationale behind this policy. Of particular note in discussion was the difficulty of weekly eligibility checks.

Curran made a motion to adjourn. Motion was seconded by Freese. Voice vote was taken. All ayes. Motion carried. Meeting adjourned at 8:12pm.
