# COVID-19 (Novel Coronavirus) FAQ for Illinois Families WHERE TO GET HELP

#### **MEALS**

- Districts are encouraged to provide meals for all children that need them, in a way that is convenient such as allowing families to "grab-and-go." Check with your district for meal pick-up/drop-off options and to find out how meals will be distributed.
- Illinois' Pandemic Electronic Benefit Transfer (P-EBT) program is now funded to provide additional benefits to all SNAP-eligible households with school-aged children. These new benefits will automatically be added to family Link cards. Households that do not currently receive SNAP benefits but are eligible for free or reduced meals while school is in session will be able to apply for P-EBT benefits. #### **CHILDCARE**

- Under the Stay at Home order, childcare centers are closed to the general public.
- Many are currently applying to be licensed as emergency childcare centers to provide childcare to essential/emergency workers only.

#### **UNEMPLOYMENT + HOUSING**

- The Governor has banned all evictions statewide during the duration of the COVID-19 emergency disaster declaration. Unemployment benefits may be available to individuals whose unemployment is related to COVID-19. # **LEARNING + INSTRUCTION**

- Beginning March 31 and through the end of the 2019-20 school year, Illinois public schools will move into Remote Learning Days that will count as Instructional Days. During this time, schoolwork will be given and graded, however, ISBE says that work completed during school closures must not negatively impact grades or academic standing, taking into account the fact that students have different access to support and technology at home. In addition, ISBE provides that schools may allow student work during school closures only to increase a student's academic standing. Please contact your district for information on their Remote Learning Plan for all students, including students with special needs.
